shall be the same as that during the immediately prior Renewal Term unless Company provides Customer written notice of a price increase at least 60 days before the end of such prior Renewal Term, in which case the price increase shall be effective upon renewal and thereafter. Any such pricing increase shall not exceed 7% over the pricing for the relevant Product or Service in the immediately prior Term.

Upon signature by Customer and submission to Company, this Order Form shall become legally binding unless this Order Form is rejected by Company for any of the following reasons: (1) the signatory below does not have the authority to bind Customer to this Order Form; (2) changes have been made to this Order Form (other than completion of the purchase order information and the signature block); or (3) the requested purchase order information or signature is incomplete or does not match our records or the rest of this Order Form. Subscriptions are non-cancelable before the expiration of any Term.
